

The LIPG brokered the sale of former Ritz-Carlton Golf Club and Spa (now Trump National) in 2012. Steve Ekovich, the lead agent on the asset sale, represented the seller and also facilitated the buyer, The Trump Organization, in the acquisition of the property. Mr. Ekovich said that "after an exhaustive international search for the right buyer for this club, it was determined that Trump would be the best fit for both the seller and club members.

Our marketing process procured buyers throughout the US and all over the world who were interested in this property because of the exceptional quality of the facility and the location. The deal making process was very complex as a result of the golf course and residential elements being intertwined from a service and maintenance standpoint within the resort operations. The Trump Organization has big plans for the property which will be renamed Trump National Golf Club, Jupiter. Very few buyers possessed the level of sophistication to deal with the complicated shared services agreement like The Trump Organization was able to do.

The LIPG has extensive access and relationships with tens of thousands of investors, and the overall marketing process ensures maximum property exposure amongst clients from various capital backgrounds and industry experience.



"Prudential had the pleasure of working with Steve Ekovich and his group on the sale of Ford's Colony, a three-course golf country club and resort in Williamsburg, VA. Ford's Colony is a semi-private club located in a master-planned community that is also adjacent to, and provides golf amenities for, a 200-room Marriott Manor Timeshare.

At the onset of the assignment, we looked at a number of the major golf brokers to determine the best fit for this assignment. Steven Ekovich, National Managing Director of the firm's Leisure Investment Properties Group and lead agent on the \$10,500,000 portfolio asset sale as listed, represented both the seller, a well-known national lender and the buyers, ClubLink and ClubCorp. The TPCs were sold out of receivership, on behalf of their legal owner and their financial institution.

Ekovich stated, "The TPC Portfolio sold in two tranches to a team of buyers. The first, TPC Eagle Trace, purchased by ClubLink, closed in a record 14 days. Clublink had an outstanding grasp of complex issues and had a full staff devoted on both sides of the transaction for the expedited close, which was essential for the TPC Eagle Trace transaction. TPC Eagle Trace is the thirteenth golf course in which I have personally represented ClubLink on in the US." ClubLink President and CEO, Rai Sahi states, "The acquisition of this prestigious club demonstrates our commitment to providing our more than 20,000 members in Florida, Ontario and Quebec the opportunity to truly experience 'One Membership, More Golf'. Since our founding in 1993, this has been our unique business model and on that continues to be successful." Ekovich continues, "ClubCorp, the largest owner of clubs in the world located in Dallas, Texas, showcased their Warchest of funds from its recent IPO; as well as their entrepreneurial platform. Most larger companies are hesitant in the decision-making department, but ClubCorp's culture allows for quick business decisions in purchasing TPC Piper Glen and TPC Dearborn properties. Their professional deal team was able to implement a very quick due diligence process and closed the transactions faster than many non-institutional buyers could have."

The Leisure Investment Properties Group marketed these properties nationally and internationally and received 20 offers on the properties. After careful consideration, the Receiver and financial institution decided it was in the best interest of all parties, including the members, to accept ClubLink and ClubCorp's offers. ClubCorp has plans to immediately begin capital expenditure projects for both remedial improvements and upgrades at both TPC properties. The vision at ClubCorp is to restore the TPC properties to the original standards set by the Tournament Players Club by investing considerable capital improvement funds." ClubLink will be doing the same with Eagle Trace. Ekovich continues, "As ClubCorp recently went public, this acquisition of the TPC portfolio is another statement to their shareholders that ClubCorp is aggressive in growing their business with quality assets."

Director of Operations




